#### **POOMSAE** (Forms, Patterns)

Poomsae competition is open to all traditional styles (a recognized style containing traditional techniques, no acrobatics or creative/musical forms). Divisions will be divided by age, belt rank and gender and all styles shall compete within same divisions. May combine or divide weight categories depending on the size of the group. Competitors should perform the form appropriate to their rank. Color-belts may repeat their forms in the final and Grand Championship Rounds. Black Belt competitors may not repeat same form in the final and Grand Championship Rounds. Competitors will be judged on balance, stance, focus, technique fluidity and power.

#### POINT SPARRING

Traditional Taekwondo point sparring rules will be used at this event. LIGHT/CONTROLLED head contact will be allowed by hand and foot techniques only to the areas covered by headgear, excluding the back of the head - face contact is not allowed. Single points shall be awarded for any clean/successful strikes to the body by either hand or foot as well as clean/successful hand strikes to the head under above restrictions. Two points shall be awarded for any clean/successful strikes by the foot to the head under the above restrictions. Matches shall be single elimination, one round and have a total run time of two minutes.

Mandatory Sparring Equipment: Head gear, foam fist guards, foam foot protectors, mouth guard and groin cup (males).

Optional Sparring Equipment: face shields, chest protectors, shin/forearm protectors

DKFA provides no competitor gear. We will not require any particular color gear

#### MEAPONS

Weapons competition is open to all traditional styles. No sharpened weapons are permitted. Weapons may not leave competitor's hands at any time during competition. Divisions will be divided by age, belt rank and gender and all styles shall compete within same divisions.

#### BBEAKING

Competitors will have 3 stations to demonstrate a breaking technique. Each station will have only one breaking technique but may have as many boards as competitor wishes. Techniques demonstrated should be appropriate to competitors belt rank. Divisions will be divided by age, belt rank and gender and trophies shall be awarded for 1st and 2nd place while medals will go to 3rd, 3rd and 3rd. Boards must be purchased at the tournament.
